Bids received that exceed the ABC shall be rejected. Late bids shall not be accepted. Prospective bidders should have experience in undertaking a similar project with an amount of at least fifty percent (50%) of the ABC. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least Seventy Five percent (75%) interest of outstanding capital stock belongs to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138 for Infrastructure projects and at least Sixty (60%) for procurement of Goods projects.
